9. Old Business

a) Planning for the Future - Trustee Frank informed the board that he has spoken with a number of Realtor's who thought they had properties for the location of the Cemetery expansion and at this moment there is still just one that is out there, but the problem is that the property is outside of the City of Simi Valley, and there would have to be an annexation and the problems that go with that, as well as a SOAR problem, so at this moment we just don't have a location, but he is continuing to work with a series of people to see if we can get a donation and or buy it, in regards to the financing, we will need an extremely large amount of money for roadways, and improvements just to prepare the land for a Cemetery, the next step is to look at grants, so he just began looking at grants both nationally and here in California, Chairman Saunders stated it is best to first have the funding in place to purchase and develop the land before looking for land. The CMS suggested that the board consider vacating the road between sections 3 and 4 to create more plots, Chairman Saunders asked that the CMS put that item on the next agenda for a vote. The CMS will attempt to find out from the board treasurer how much it cost to vacate the road, the CMS also asked the board to consider adding an ADU to the property and turning the 800 square foot garage into an apartment to build revenue, Chairman Saunders asked the CMS to add these items to the next month's agenda for discussion

b) Hiring a Surveyor to Map Sections NE1 & NW1 -
